On a lovely warm sunny day, I met a smiling Linda Rodrigues, one of the owners of Quiet Walker Lodge. At the door of the solarium, I was astounded by the sight of waterfalls cascading into a sparkling koi pond. Linda said, "The koi were flown from

We fell in love with the Dubuque County area and bought the lodge. We updated the main lodge and built the new Wakatanka House addition in 2010. The location serves as both a bed and breakfast and a place for us to do ministry. The new addition has a conference room which can handle up to 30 people, and it has been used by churches for small meetings, businesses, and special events groups. This past year we held the Quad City Basket Weaving Convention at the lodge."

Linda explains, "We are proud of our bed and breakfast and the quality of service we can provide our guests." The main lodge features five themed suites each with a bubble up or champagne whirlpool tub. There is also a party grill outside for those guests who wish to barbecue. Outdoor games

and indoor games are also available. This part of the bed and breakfast also features a great room and dining area."

The Wakatanka House has four suites with a Native American décor and spacious whirlpool tubs. All rooms have zoned heating and air conditioning. The Lakota suite, which is on the first floor, is also handicap accessible with a roll in shower. There is also an elevator for disabled people to use to get to the second floor and enjoy the loft area which overlooks cathedral windows. The wine tasting area featuring native Iowan wine for the guests is very popular.

The Moonlight and Roses suite is a special suite featuring wrap around windows to give the guests a feeling of the outdoors. This room is popular with couples who are having their wedding at the lodge or are enjoying their honeymoon here. Linda offers the use of the

property for small garden weddings. Brides love the spectacular grounds for their wedding pictures, many preferring to get married under the weeping willow tree. Hy-Vee provides catering for private events and florists deliver to the site.

Linda's friendliness and love for Iowa helps make Quiet Walker Lodge a special place to visit. Linda maintains the grounds and has two greenhouses where she grows beautiful roses and flowers for the lodge as well as some of the fruits used in the breakfasts. She is also in the process of restoring the forest reserve surrounding the lodge and creating a song bird garden for guests to enjoy.

Linda can't say enough about innkeeper Carol Chalberg. Carol is the queen of hospitality and has lived and worked in England and has directed major special events. Carol enjoys providing that special touch whether it is in decorating the lodge for different holidays or providing that extra special

Third Party Notification

Maquoketa Valley Electric Cooperative's third party notification plan allows our members to designate a third party to receive copies of any notices that might be received for discontinuation of electric service.

The purpose of this program is to limit the risk of a member having the electric service discontinued because of a breakdown in communication. Example, a member missed receiving the notice or received it but did not understand the implications.

Copies of the notifications may be sent to any third party; a relative, friend, clergyman, physician, landlord, agent or agency, etc., designated by the member. Even though the third party serves as an additional communication link with the member, the third party is not placed under any obligation to pay the electric bills. Third party notification does not defer or prevent discontinuing the electric service if payment is not made.

Although we will make every effort to provide third party notification, the member making this request agrees that Maquoketa Valley Electric Cooperative incurs no liability whatsoever for failure to do so for any reason.
